**RESOLUTION ACCEPTING THE DONATION OF SURPLUS MOTOR VEHICLES BY
FORSYTH TECHNICAL COMMUNITY COLLEGE TO FORSYTH COUNTY

WHEREAS, Forsyth Technical Community College owns three (3) motor vehicles, identified in the attached memorandum from Kenneth Jarvis to Kevin Rogers dated March 22, 2017 and incorporated herein by reference, which vehicles are no longer useful and have been declared surplus by Forsyth Technical Community College; and

WHEREAS, Forsyth Technical Community College desires to donate the three surplus vehicles to Forsyth County and County staff recommends that the vehicles be accepted by Forsyth County;

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby accepts, on behalf of Forsyth County, the donation from Forsyth Technical Community College to Forsyth County of the motor vehicles identified as follows:

BE IT FURTHER RESOLVED that the Chairman or the County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, the necessary documents to receive title to the said vehicles on the conditions that said vehicles shall be used or disposed of and the proceeds thereof used by Forsyth County as an addition to the County's active fleet and that Forsyth County shall waive all rights to make any claims against Forsyth Technical Community College relating to any failure of performance of said vehicles, to which the County agrees by accepting title to the vehicles, all subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
