**SUMMARY OF INFORMATION:**

On June 27, 2016, the Forsyth County Board of Commissioners adopted the 2016 New Family Museum Capital Projects Ordinance to account for funds to assist with the construction of a new family museum, facilitated by the merger of the Children's Museum of Winston-Salem and SciWorks. The Capital Projects Ordinance (CPO) was named New Family Museum because the name of the new museum had not been announced at the time.

On February 7, 2017, the name Kaleideum, combining kaleidoscope and museum, was announced for the museum. In order to match up the Capital Projects Ordinance that captures revenues and expenditures for this project, with the museum name, an amendment is necessary to rename the CPO.

This Capital Projects Ordinance is funded with revenue from the Sale of Surplus Property, a Transfer from the General Fund, a grant from the North Carolina Cultural Resources Museum, and Other Sales.
