SUMMARY OF INFORMATION:

Estimated sales tax proceeds allocated in the FY 2018-2019 Fire Tax District Special Revenue Fund and the Budget Ordinance based on the ad valorem method are transferred to the General Fund to support County Fire Protection. In the current fiscal year, it is projected that actual revenues will exceed estimates in twenty-two districts and an amendment to the FY 2018-2019 Fire Tax District Special Revenue Fund and Budget Ordinance are necessary in order to increase appropriations so that amounts in excess of original estimates may be transferred to the General Fund. The FY 2018-2019 Fire Tax District Special Revenue Fund and Section 9 of the FY 2018-2019 Budget Ordinance provide for the appropriations to the fire and fire/rescue protection districts. The Finance Department requested these 2018-2019 Fire Tax District Special Revenue Fund and Budget Ordinance revisions for year-end preparation.
