### AARP WS Tax-Aide – Begins Feb. 1, 2023

AARP Tax-Aide prefers, but does not require, that the taxpayer has an email account.

1. Obtain a tax packet from one of the library branches listed below (or visit [www.wstaxaide.com](http://www.wstaxaide.com) and print the forms).
2. Follow the instructions in the tax packet, including scheduling an appointment.
3. Appointments take place on the days listed below from 9 a.m. to 1 p.m. at one of the following library branches:
  - **Mondays and Tuesdays** at Reynolda Manor Branch, 2839 Fairlawn Dr., Winston-Salem
  - **Wednesdays** at Clemmons Branch, 6365 James St., Clemmons
  - **Thursdays and Fridays** at Southside Branch, 3185 Buchanan St., Winston-Salem

**What to bring:** Photo ID for taxpayer (and spouse if filing jointly); Social Security ID or ITIN ID of each person on the tax return; W-2s, 1099s, social security statements (SSA-1099), all documents reflecting earnings; last year's tax return; all childcare provider names, addresses and employer ID numbers (EIN) or SS numbers; CP01A Notice (Identity Protection PIN); evidence of deductible expenses; income and expenses for sole proprietorship (Schedule C); 1095-A form if healthcare coverage is through Marketplace (ACA) insurance; and checking or savings account number for direct deposit of a refund.
