ASSUMPTION OF RISK ACKNOWLEDGEMENT

I also understand that there may be other risks not reasonably foreseeable at this time.

I choose to participate and/or allow my minor child to participate in the Activity in spite of these risks and I accept and assume ALL risks and ALL responsibility for losses, costs and damages I and/or my minor child incur as a result of my and/or my minor child's participation in the Activity. I understand the nature of the Activity and I represent that I and/or my minor child am qualified, in good health, and in proper physical condition to participate in the Activity. If, during the Activity, it appears that my and/or my minor child's qualifications, health, or physical condition are no longer sufficient to meet the continuing demands of the Activity, I and/or my minor child will immediately discontinue that participation.

RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

I further agree that if I or anyone on my and/or my minor's behalf makes a claim or demand against any of the releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which any may incur as the result, including but not limited to the costs of reasonable attorneys fees incurred to defend the claim.
